When the flying field now known as Randolph Air Force Base was activated in 1931, it provided a new home for an institution with traditions reaching back to World War I: the School of Aviation Medicine.

The air cadets for whom Randolph was planned have long since moved away to other bases. The training squadrons and commands have changed. The aircraft that used to land on runways of green turf have departed. Only the School of Aviation Medicine remains at Randolph, unaltered except in size, after twenty-four years.

Not only is it the oldest establishment on the Base. It is probably the oldest organization in the Air Force that has continued without interruption on the mission for which it was originally created.

The School of Aviation Medicine was founded in January 1918 to perform research on conditions affecting the fitness and efficiency of military flyers. A school for flight surgeons was added to it the next year.

Its first headquarters were at Hazelhurst Field on Long Island, New York. After moving for a time to neighboring Mitchel Field, it was transferred in 1926 to Brooks Field, Texas, and remained there until its present quarters were occupied at Randolph.

The School has no connection with either the Air Training Command or Crew Training Air Force, the other two major components represented at Randolph. It is a part of the Air University system, responsible to the headquarters of that command at Maxwell Air Force Base in Montgomery, Alabama.

It performs three main functions. As a research institute, it is the central Air Force laboratory for studies of the basic medical problems of men who fly. Every circumstance that might affect the airman's well-being comes under the scrutiny of its military and civilian doctors, from airsickness to vision at supersonic speeds, from noise hazards to escape from rocket craft twenty miles above the earth.

As an education institution, the School is charged with the instruction of all Air Force medical personnel in the specialized procedures used to guard the flyer's health. Since October 1950, only medical officers have been taught at the Randolph headquarters. The School offers (a primary course, surveying the field of aviation medicine; an advanced course for officers who wish to make this branch of medicine their careers; a refresher course for older flight surgeons; and a review course to prepare experienced surgeons for their specialty board examinations.

At Gunter Air Force Base, also in Montgomery, Alabama, is a branch of the School that handles the greater part of its teaching. The students there include Navy and Air Force flight nurses, officers newly commissioned in the medical services, experts in medical administration and supply, laboratory assistants, supervisors, and hospital technicians. The Gunter Branch was opened after the outbreak of war in Korea, when the School outgrew the facilities available at Randolph.

Finally, the School's flight surgeons use their specialized knowledge of aviation medicine to diagnose unusual cases referred to them for consultation by the Surgeon General. These patients are rated pilots or crew members with difficult or obscure conditions that may affect their flying status.

Brigadier General Edward J. Kendricks, who has headed this unique organization since 1953, is the twelfth of a distinguished line of medical officers to serve as the School's Commandant. His predecessors have included Dr. Louis H. Bauer, past President of the American Medical Association, and Major General Harry G. Armstrong, former surgeon General of the Air Force.

In 1942 he was appointed Surgeon of a highly secret aerial task group known as the "Halverson

Along with the transfer of Brooks, ATC passed to AFSC (and its newly formed Aerospace Medical Division at Brooks) control of the USAF Aerospace Medical Center, the School of Aerospace Medicine, the USAF Hospital Lackland, and the 3790th Epidemiological Laboratory. (The School of Aviation Medicine had been redesignated as the School of Aerospace Medicine on 8 May 1961.) However, the Medical Service School at Gunter remained in the command, reassigned from the medical center to Headquarters ATC on 1 October.

Brooks and Aerospace Medical Center

In 1959 the Air Force put medical education and training and space medical research responsibilities under the direction of Air Training Command. Headquarters USAF directed that Continental Air Command transfer Brooks AFB, Texas, to ATC on 1 October. At the same time, ATC activated the USAF Aerospace Medical Center at Brooks, and, concurrently, Air University issued orders reassigning the School of Aviation Medicine at Brooks to ATC and the aerospace medical center. In addition, ATC reassigned the USAF Hospital Lackland from the Lackland Military Training Center to the medical center. The last action, the organization of the 3790th Epidemiological Laboratory at Lackland, took place on 1 November; ATC assigned the lab to the medical center. The addition of all of these units increased ATC's assigned personnel strength by 4,965.

From 1931 until 1959, the School of Aviation Medicine was located at Randolph AFB, Texas, whereupon it moved across town to Brooks AFB. Shown above is the research laboratory at Randolph.

Brooks AFB, Texas

On 1 November 1961, ATC transferred Brooks AFB to Air Force Systems Command (AFSC). This was all part of an Air Force plan to reorganize aerospace medical research. Along with the transfer of Brooks, ATC passed to AFSC (and its newly formed Aerospace Medical Division at Brooks) control of the SAF Aerospace Medical Center, the School of Aerospace Medicine, the USAF Hospital Lackland, and the 3790th Epidemiological Laboratory. (The School of Aviation Medicine had been redesignated as the School of Aerospace Medicine on 8 May 1961.) The Medical Service School at Gunter remained in the command, reassigned from the medical center to Headquarters ATC on 1 October.

Not only is it the oldest establishment on the Base. It is probably the oldest organization in the Air Force that has continued without interruption on the mission for which it was originally created.

The School of Aviation Medicine was founded in January 1918 to perform research on conditions affecting the fitness and efficiency of military flyers. A school for flight surgeons was added to it the next year.

Its first headquarters were at Hazelhurst Field on Long Island, New York. After moving for a time to neighboring Mitchel Field, it was transferred in 1926 to Brooks Field, Texas, and remained there until its present quarters were occupied at Randolph.

The School has no connection with either the Air Training Command or Crew Training Air Force, the other two major components represented at Randolph. It is a part of the Air University system, responsible to the headquarters of that command at Maxwell Air Force Base in Montgomery, Alabama.

It performs three main functions. As a research institute, it is the central Air Force laboratory for studies of the basic medical problems of men who fly. Every circumstance that might affect the airman's well-being comes under the scrutiny of its military and civilian doctors, from airsickness to vision at supersonic speeds, from noise hazards to escape from rocket craft twenty miles above the earth.

As an education institution, the School is charged with the instruction of all Air Force medical personnel in the specialized procedures used to guard the flyer's health. Since October 1950, only medical officers have been taught at the Randolph headquarters. The School offers (a primary course, surveying the field of aviation medicine; an advanced course for officers who wish to make this branch of medicine their careers; a refresher course for older flight surgeons; and a review course to prepare experienced surgeons for their specialty board examinations.

At Gunter Air Force Base, also in Montgomery, Alabama, is a branch of the School that handles the greater part of its teaching. The students there include Navy and Air Force flight nurses, officers newly commissioned in the medical services, experts in medical administration and supply, laboratory assistants, supervisors, and hospital technicians. The Gunter Branch was opened after the outbreak of war in Korea, when the School outgrew the facilities available at Randolph.

Finally, the School's flight surgeons use their specialized knowledge of aviation medicine to diagnose unusual cases referred to them for consultation by the Surgeon General. These patients are rated pilots or crew members with difficult or obscure conditions that may affect their flying status.

Brigadier General Edward J. Kendricks, who has headed this unique organization since 1953, is the twelfth of a distinguished line of medical officers to serve as the School's Commandant. His predecessors have included Dr. Louis H. Bauer, past President of the American Medical Association, and Major General Harry G. Armstrong, former surgeon General of the Air Force.

In 1942 he was appointed Surgeon of a highly secret aerial task group known as the "Halverson

General Kendricks remained with the Ninth Air Force as its Surgeon until the end of the War. Afterwards he was Director of Medical Staffing and Education in the Office of the Surgeon General, until he assumed command of the School.

The Deputy Commandant is Colonel John R. McGraw, former Surgeon of the Ninth Troop Carrier Command in Europe and of the Thirteenth Air Force in the Philippines.

The Gunter Branch is under the command of Colonel Fratis L. Duff, who served with General Kendricks in the Ninth Air Force while it was In Egypt, and later with the Far East Air Force in Japan.

Brooks and Aerospace Medical Center

In 1959 the Air Force put medical education and training and space medical research responsibilities under the direction of Air Training Command. Headquarters USAF directed that Continental Air Command transfer Brooks AFB, Texas, to ATC on 1 October. At the same time, ATC activated the USAF Aerospace Medical Center at Brooks, and, concurrently, Air University issued orders reassigning the School of Aviation Medicine at Brooks to ATC and the aerospace medical center. In addition, ATC reassigned the USAF Hospital Lackland from the Lackland Military Training Center to the medical center. The last action, the organization of the 3790th Epidemiological Laboratory at Lackland, took place on 1 November; ATC assigned the lab to the medical center. The addition of all of these units increased ATC's assigned personnel strength by 4,965.

From 1931 until 1959, the School of Aviation Medicine was located at Randolph AFB, Texas, whereupon it moved across town to Brooks AFB. Shown above is the research laboratory at Randolph.

Brooks AFB, Texas

On 1 November 1961, ATC transferred Brooks AFB to Air Force Systems Command (AFSC). This was all part of an Air Force plan to reorganize aerospace medical research. Along with the transfer of Brooks, ATC passed to AFSC (and its newly formed Aerospace Medical Division at Brooks) control of the SAF Aerospace Medical Center, the School of Aerospace Medicine, the USAF Hospital Lackland, and the 3790th Epidemiological Laboratory. (The School of Aviation Medicine had been redesignated as the School of Aerospace Medicine on 8 May 1961.) The Medical Service School at Gunter remained in the command, reassigned from the medical center to Headquarters ATC on 1 October.

Brooks Says Goodbye to Me
